### WCC Supports Adoption Tax Credit

In [testimony](#) submitted on January 11, the WCC urged members of the Assembly Committee on Children and Families to support [Assembly Bill 287](#) (Rep. Kathleen Bernier, R-Chippewa Falls). This bi-partisan bill would create a nonrefundable individual state tax credit of up to \$5,000 for qualified adoption expenses. The Committee took no further action on the bill.

[SB-325](#). **Concealed Carry** (JCRAR) Training requirements for licenses to carry a concealed weapon. *To Senate Organization.*

[SB-336](#). **Wisconsin Shares** (Taylor) Time limits and other participation requirements, case management services, and caretaker of newborn grants under Wisconsin Works; childcare provider rates and eligibility subsidies under Wisconsin Shares. *To Public Health, Human Services and Revenue.*

[SB-343](#). **Health Benefit Plans.** (Erpenbach) Requires certain medical loss ratios for health benefit plans. *To Insurance and Housing.*

[SB-345](#). **Statute of Limitations** (Lassa) Changes to the statute of limitations for sexual contact with a child. *To Judiciary, Utilities, Commerce, and Government Operations.*

[SB-350](#). **Domestic Abuse** (Olsen) Increased penalty for repeated domestic abuse offenses. *To Judiciary, Utilities, Commerce and Government Operations.*

[SB-353](#). **Public Schools** (Olsen) The use of seclusion and physical restraint on pupils in public schools. *To Education.*

[SB-355](#). **Minors** (Lassa) The hours that a minor may work. *To Economic Development and Veterans and Military Affairs.*

[SB-358](#). **Alcohol** (Galloway) Alcohol beverages violations by underage persons on licensed premises. *To Judiciary, Utilities, Commerce, and Government Operations.*

[SB-360](#). **Prescription Drugs** (Vukmir) Repeals minimum markup sale price on prescription drugs. *To Health.*

[SB-361](#). **Work-Based Learning** (Vukmir) Payments to the Second Chance Partners for Education and other nonprofit corporations that operate programs in

which disengaged pupils participate in work-based learning programs while earning high school diplomas. *To Education.*

[SB-362](#). **Tax Exemption** (Grothman) A sales and use tax exemption for building materials that become a part of a facility for a local unit of government or nonprofit organization. *To Tax Exemptions.*

[SB-364](#). **Income Tax Deduction** (Grothman) Creates an individual income tax deduction for certain contributions to a Coverdell Education Savings Account. *To Financial Institutions and Rural Issues.*

[SB-372](#). **Child Care Centers** (S. Coggs.) Inspections of unlicensed child care centers, a hotline to receive reports of alleged unlicensed child care centers, and an unlicensed child care center public information and education campaign. *To Labor, Public Safety, and Urban Affairs.*

[AB-415](#). **Juvenile Records** (Kestell) Use of law enforcement or juvenile court records to take disciplinary action against a pupil under a school district's athletic code. *To Education.*

[AB-434](#). **Pregnancy Centers** (E. Coggs) False advertising by limited services pregnancy centers. *To Health.*

[AB-436](#). **Conviction Records** (C. Taylor) Prohibits consideration of the conviction record of an applicant for employment before the applicant has been selected for an interview. *To Criminal Justice and Corrections.*

[AB-437](#). **Veterans** (Wynn) An income and franchise tax credit for hiring unemployed disabled veterans. *To Veterans and Military Affairs.*

[AB-443](#). **Workers Compensation** (Fields) Excludes sports officials from coverage under the worker's compensation law. *To Labor and Workforce Development.*

[AB-444](#). **Voting** (Grigsby) Restores the right to vote to certain persons barred from voting as a result of a felony conviction, changes the information required on voter registration forms, and changes voting procedure for certain persons who are convicted of felonies. *To Election and Campaign Reform.*

[AB-445](#). **Minors** (Grigsby) The hours a minor may work. *To Labor and Workforce Development.*

[AB-446](#). **Childcare** (Grigsby) Time limits and other participation requirements, case management services, and caretaker of newborn grants under Wisconsin Works; child care provider rates and eligibility for subsidies under Wisconsin Shares. *To Children and Families.*

[AB-448](#). **Abortions** (Craig) A prohibition on partial-birth abortions. *To Health.*

[AB-449](#). **Domestic Abuse** (A. Ott) Increased penalty for repeated domestic abuse offenses. *To Criminal Justice and Corrections.*

[AB-451](#). **Work-Based Learning** (Farrow) Payments to the Second Chance Partners for Education and other nonprofit corporations that operate programs in which disengaged pupils participate in work-based learning programs while earning high school diplomas. *To Education.*

[AB-455](#). **Restraints** (Kestell) The use of seclusion and physical restraint on pupils in public schools. *To Education.*

[AB-458](#). **Health Benefits** (Richards) Requires certain medical loss ratios for health benefit plans. *To Insurance.*

[AB-460](#). **IDs for Voting** (C. Taylor) Use of university, college, or technical college identification cards as proof of identification for voting. *To Election and Campaign Reform.*

[AB-461](#). **Statute of Limitations** (Pasch) Changes to the statute of limitations for sexual contact with a child. *To Criminal Justice and Corrections.*

[AB-464](#). **Alcohol Violations** (Jacque) Alcohol beverages violations by underage persons on licensed premises. *To Judiciary and Ethics.*

[AB-466](#). **Income Tax Deduction** (Thiesfeldt) Creates an individual income tax deduction for certain contributions to a Coverdell Education Savings Account. *To Ways and Means.*

[AB-469](#). **Electronic Smoking Devices** (Kooyenga) Exempts electronic smoking devices from the types of smoking devices that may not be used in certain locations. *To Homeland Security and State Affairs.*

[AB-471](#). **Disabilities** (Severson) Changes terminology for those with an intellectual disability. *To Health*.

[AB-474](#). **Medical Assistance** (Mason) Changes the deadline for approval of a certain federal law waiver request affecting the Medical Assistance program. *To Insurance*.
